COMPLAINT

Plaintiff, Montelican Publishing, Inc., a not-for-profit entity, with an address at Student Center Annex, Room #113, One Normal Avenue, Montclair, New Jersey, says:

PARTIES

- Plaintiff, Montelican Publishing, Inc., is a not-for-profit entity with an address at Student Center Annex, Room #113, One Normal Avenue, Montclair, NJ 07043.
- Plaintiff, Montelican Publishing, Inc., publishes The 2. Montclarion, a student newspaper for the benefit of the Montclair State University community.

- 3. The Montclarion has been circulated to and within Montclair State University since in or about 1926, first known as the The Pelican and then subsequently renamed The Montclarion.
- 4. Defendant, Student Government Association, Inc. ("SGA"), is a student-run corporation incorporated under the laws of the State of New Jersey.
- 5. Formed in 1925 as "The Student Council" and incorporated in 1934 as "The Student Government Association," the SGA office is located in the Student Center Annex, Room 103, Montclair, New Jersey 07043.
- 6. Defendant, SGA is composed of the three separate but equal bodies, the Executive, the Legislative, and the Judicial branches.
- 7. Montclair State University, a public higher education institution formed under the laws of the State of New Jersey, has authorized the SGA to receive, disburse and appropriate, in SGA's discretion, monies collected by Montclair State University through mandatory student fees. The SGA, in its discretion, disburses and appropriates such public monies to more than 100 student organizations, including groups for public service, culture, arts, hobbies, sports, and greek life. It also, in its discretion, charters student-run organizations.

NATURE OF THE CAUSES OF ACTION

- 8. On February 4, 2009, the Defendant SGA held a public meeting at the Montclair State University Student Center, Room 411, to discuss matters pertaining to appropriations of public funding. (Exhibit A)
- During said meeting, the Defendant SGA moved to go into closed session, and remained in closed session for approximately one hour.
- 10. The resolution authorizing the closed session provided no details about what was to be discussed, nor was there notice, prior to the resolution, that the SGA would be going into closed session.
- 11. On February 5, 2009, The Montclarion requested the meeting minutes for the closed session of the SGA meeting held on February 4, 2009. (Exhibit B)
- 12. On February 11, 2009, The Montclarion received the meeting minutes regarding only the public session of the SGA meeting. (Exhibit C) The provided meeting minutes note that the SGA went into closed session. No details about the closed session are provided. (Exhibit C, p.10)
- 13. On March 4, 2009, The Montclarion submitted another request for the meeting minutes from SGA's closed session. This request was made pursuant to the Open Public Records Act,

- N.J.S.A. 47:1A-1, et. seq. ("OPRA"); Open Public Meetings
 Act, N.J.S.A. 10:4-6, et. seq. ("OPMA"); and the common law
 right of citizens to access public documents. The same
 request was submitted to the SGA offices and the University
 Counsel of Montclair State University.
- 14. On March 5, 2009, SGA President, Ron Chicken, denied The Montclarion's request for the minutes of the closed session, stating that "[OPMA] does not apply to the [SGA]." (Exhibit D)
- 15. On March 6, 2009, Montclair State University also denied

 The Montclarion's request, stating: 1) the SGA is not a

 public body as defined by OPMA; 2) SGA meetings minutes do

 not constitute a "government record" as defined by OPRA;

 and, 3) minutes of the SGA are not public documents subject

 to the common law right of citizens to obtain access to

 public documents. (Exhibit E)
- 16. To date, Defendant SGA has failed to provide any explanation about why the board went into closed session on February 4, 2009, what was discussed, or when such information will be made public.
- 17. To date, Defendant SGA has failed to release the minutes from the SGA's closed session on February 4, 2009.

FIRST COUNT

The SGA's closed session on February 4, 2009 violated OPMA

- 18. Defendant SGA constitutes a "public body" as defined under OPMA because it "perform[s] a public governmental function affecting the rights, obligations, privileges, benefits or legal relations of any other person" or alternatively, because it is "collectively authorized to spend public funds."
- 19. Because the SGA is a "public body," the SGA must comply with the provisions of OPMA.
- 20. On February 4, 2009, the SGA violated OPMA by going into a closed session without adopting a resolution that satisfies the requirements of OPMA.
- 21. Defendant SGA's resolution failed to comply with OPMA because it provided absolutely no details about what was to be discussed in closed session.
- 22. The SGA's motion specifically failed to state a) the general nature of the subject to be discussed; and b) time when and the circumstances the discussion could be disclosed to the public, in violation of N.J.S.A. 10:4-13.

23. The SGA further violated OPMA because it failed provide adequate notice of the closed session in violation of N.J.S.A. 10:4-8(d).

WHEREFORE, Plaintiff demands judgment against the Defendant:

- (a) Declaring the SGA, as an entity "perform[ing] a public governmental function affecting the rights, obligations, privileges, benefits or legal relations of [another] person" and "collectively authorized to spend public funds," subject to the provisions of OPMA.
- (b) Declaring the closed session of the SGA on February 4,2009, in violation of OPMA.
- (c) For fees and costs of suit.
- (d) For such other relief as this Court may deem equitable and just.

SECOND COUNT

The SGA's failure to provide meeting minutes from the closed session on February 4, 2009 violated OPMA.

- 24. Plaintiffs repeat all of the allegations of the First Count and make them a part hereof as if set forth at length.
- 25. Defendant SGA as a "public body" has failed to keep "reasonably comprehensible minutes" of its closed session on February 4, 2009, in violation of N.J.S.A. 10:4-14.
- 26. The Defendant SGA further failed make the meetings minutes of the closed session on February 4, 2009, "promptly available" to The Montclarion in violation of N.J.S.A. 10:4-14.

WHEREFORE, Plaintiff demands judgment against the Defendant:

- (a) Declaring the SGA, as an entity "perform[ing] a public governmental function affecting the rights, obligations, privileges, benefits or legal relations of [another] person" and "collectively authorized to spend public funds," subject to the provisions of OPMA.
- (b) Compelling the SGA to immediately provide the minutes from the closed session on February 4, 2009.

- (c) For fees and costs of suit.
- (d) For such other relief as this Court may deem equitable and just.
